Carol has been drawing and painting since childhood. Her college degree includes a major in art and a minor in mathematics. She has been a teacher, a graphic artist, commercial photographer, and art director. Most of her paintings are acrylic, sometimes with mixed media and collage. The artwork reflects a “discussion” between the artist and the painted image as it develops. The process results in intuitive color and texture tempered by rational composition and detail. Carol is a signature member of the NWS, WFWS, and SDWS.

Entry Fees

\$25 for one entry; \$35 for two entries; \$45 for three entries.

Presentation of Art

Work may be in any medium. 2D work may be no larger than 14 inches on any side, INCLUDING FRAME, and weigh no more than 10 lbs. Wire hangers only with ends wrapped for safety. 3D work may be no larger than 14” on any side, weigh no more than 10 lbs., and must be stable when set on a flat surface.

Delivery of Work

All artwork must be delivered on October 27, 11am-3pm. Each piece must have this information on the back: artist name, title of piece, email or phone#, and price of work. Brandon reserves the right to decline any work that does not meet its standards. Work must remain at gallery through the end of the show.

SALES: Brandon Gallery retains 30% of sales.

Artist Agreement

By submitting entry, the artist agrees to release any and all Brandon Gallery members and show judge from financial responsibility for artwork in the event of theft, fire, or any other damage while on the premises. Brandon also has permission to use photos of work for promotion.
