APPLICATION

Submission for this show will be in person only on July 28 as described below. Any questions should be directed to info@fallbrookbrandongallery.org

ENTRY FEES

\$25 for one entry; \$35 for two entries; \$45 for three or four entries.

PRESENTATION OF ART

Work may be in any medium. 2D work may be no larger than 30 inches on any side, INCLUDING FRAME, and weigh no more than 25 lbs. Wire hangers only with ends wrapped for safety. 3D work may be no larger than 18" on any side, weigh no more than 25 lbs., and must be stable when set on a flat surface.

DELIVERY OF WORK

All artwork must be delivered on July 28, 11am-3pm. Each piece must have this information on the back: artist name, title of piece, email or phone#, and price of work. Brandon reserves the right to decline any work that does not meet its standards. Work must remain at gallery through the end of the show.

SALES: Gallery retains 30% of sale price.

ARTIST STATEMENT

By submitting entry, the artist agrees to release any and all Brandon Gallery members and show judge from financial responsibility for artwork in the event of theft, fire, or any other damage while on the premises. Brandon also has permission to use photos of work for promotion.
